Previously opening permission has been accorded to the classes VIII under E.M. to AD EM School, Poolbagh, Anakapalli Mandal, Visakhapatnam District from the year 2021-22vide reference 5th cited.

In the reference 7th cited, the District Educational Officer, Visakhapatnam has verified the application and submitted for granting of Provisional Recognition for a period of 03 (Three) years i.e. from 2021-22 to 2023-2024 with reference to the Inspection Report of the Inspecting Officer (vide reference 6th cited) and as per the G.O.Ms.No.; Education, Dated.01.01.1994 and its amendments.

As per the instructions of the Director of School Education, AP, Amaravathi vide reference 9th cited read with the G.O.4th cited, under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Visakhapatnam who is the competent authority is hereby accorded Provisional Recognition for the class VIII under (E.M) in AD EM School, Poolbagh, Anakapalli Mandal, Visakhapatnam District for a period of Three (03) years i.e., 2021-22 to 2023-24 without Grant-in-Aid now or in future subject to fulfillment of the following conditions.

That the society shall abide by the rules and regulations made by the Government or authorized officer from time to time.

That the Educational Institutions shall serve the needs of the locality more particularly.

03 The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.

04 That the school timings, vacations and mid-term holidays shall be followed as prescribed by Government from time to time.

05 That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed by the management with own funds as per the staff pattern.

That the results of institution shall be satisfactory every year.

That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least. 07

- That the list of Governing Body shall be furnished to the District Educational Officer every year.

 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every 09
- 10 That all the conditions prescribed in the said G.O.'s and other orders which are not specified in this order shall be complied with,
- 17 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.

12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.

13 That the society shall submit proposal for Renewal of Recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.

The management is informed that no thatched roof accommodation is allowed to run the School. 14

The management shall provide proper adequate Toilets / sanitation facility to the students& Staff. Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises. 16

The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.

The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students. 18

The school shall have first aid kit and the teachers shall be trained in first aid. 19

That the management shall ensure the Accounts of this school are audited by an authorized Chartered Accountant every year. 20

That the management has to maintain trained and qualified of APTET Teachers at all time. 21

- The Management is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
- The management of the school is hereby informed to renew the Sanitary, Structural Soundness, and FIRE NOC certificates from the competent authority from time to time and same should be submitted to the District Educational Officer, Visakhapatnam through the inspecting officer without fail.

If the management fails to comply with the above conditions promptly failing which the Recognition now granted will be

reviewed.
