- 10. The Fire safety systems were tested by the Inspection Committee, Fire Prevention Wing, GVMC during the inspection and performance found satisfactory and recommended for issuance of Renewal of Fire No Objection Certificate.

11. Therefore, Renewal of Fire No Objection Certificate is hereby issued to the Educational Building of M/s. AD School (E.M), Phoolbagh Road Gavarapalem, Anakapalli, Visakhapatnam subject to the following conditions:

- i. All the protection arrangements shall be maintained in good condition as seen during inspection
- ii. All the escape / exit routes shall not be kept locked / blocked or encroached
- iii. All the occupants must know the correct method of operation of the fire fighting system installed
- iv. Any loss of life or property due to non-functioning of fire safety measures and other himstallations shall be the responsibility of the management.
- v. All students / staff members of the institution shall be trained to operate the fire safety

- vi. Addition / alteration, if any in the building may be obtained with prior permission from this department.
- vii. Mock drills should be conducted once in 3 months for initial two years. Thereafter, once in every 6 months.
 - 12. The Renewal of Fire No Objection Certificate issued to M/s.AD School (E.M), Phoolbagh Road Gavarapalem, Anakapalli, Visakhapatnam is valid for three (03) years from 12-11-2024 to 11-11-2027 and the Management shall submit the application for Renewal of Fire No Objection Certificate two (2) months before the date of expiry.
 - 13. The issuing of Fire NOC without any prejudice to action taken by GVMC against Unauthorized Construction, if any made.
